ARTICLES OF INCORPORATION
OF
REFINANCEFIRST.COM, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, Florida Statutes, Chapter 607, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE – Name

The name of this corporation is **REFINANCEFIRST.COM, INC.**

ARTICLE TWO – Duration

The period of its duration is perpetual.

ARTICLE THREE – Purpose

(A) To engage in the business of refinancing motor vehicles, sport utility vans and light trucks refinance, and generally to acquire any products or rights therein, maintain equipment, intellectual property, intangibles and other things in connection therewith in any state, in the District of Columbia, and in any territory, dependency, or possession of the United States, and in any foreign country;

(B) Additionally, in general to do any and all things and exercise any and all powers, rights, and privileges, which a corporation may now, or hereafter be organized to do or to exercise under the corporation laws of this state or under any act amending those laws.

ARTICLE FOUR - Capital Stock

The corporation is authorized to issue 100 shares, all of one class, at \$1.00 par value.

ARTICLE FIVE - Initial Registered Office and Agent

ARTICLE SIX - Initial Board of Directors

ARTICLE SEVEN – Incorporator

Directors need not be residents of this state or shareholders unless Articles of Incorporation or Bylaws so require.

ARTICLE NINE - Meetings by Conference Telephone

Members of the Board of Directors may participate in special, regular and annual meetings of the board of directors by means of conference telephone or similar communications equipment as provided by law.

ARTICLE TEN - Informal Action of Directors

If all the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE ELEVEN - Amendment of Articles

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.



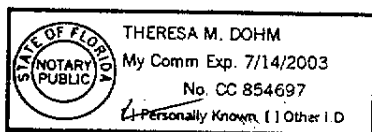
