CERTIFICATE OF INCORPORATION OF 1820 BUILDING, INC.

I, the undersigned, is desirous of forming a corporation under the laws of the State of Florida Such laws that are applicable to corporation for profit, and respectfully petition the Secretary of State for approvate such incorporation under the following proposed Certificate of Incorporation.

ARTICLE I NAME

The name of this corporation shall be **1820 BUILDING**, **INC**., and its principal place of business shall be 1820 NE 163rd Street, Suite 203, N. Miami Bëach, Florida 33162, and any other location that the Board of Directors may deem appropriate.

ARTICLE II
