ARTICLES OF INCORPORATION ON AUG 30 AM 11:54 DRAGONRIDERS CONSULTING, INCASE OF STATE THE PRINT

ARTICLE I. NAME AND ADDRESS: The name of the Corporation ESRIDA DRAGONRIDERS CONSULTING, INC., and it's principal office and mailing address is 945 NE 176th Street, North Miami Beach, Florida 33162.

ARTICLE II. REGISTERED AGENT AND ADDRESS: The Registered Agent is THOMAS DRATLER, and the initial registered office of the Corporation is 945 NE 176th Street, North Miami Beach, Florida 33162.

ARTICLE III. TERM OF CORPORATE EXISTENCE: The Corporation shall exist in perpetuity unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation by the Secretary of State of the State of Florida.

ARTICLE IV. PERMITTED ACTIVITY: The Corporation may engage in any activity of business permitted under the laws of the United States and of the State of Florida.

ARTICLE V. AUTHORIZED SHARES: The total number of shares which the Corporation is authorized to issue shall be one thousand (1,000) shares of common voting stock without par value.

ARTICLE VI. ARTICLE VII. DIRECTORS: The business of the Corporation shall be managed by a Board of Directors, consisting of not fewer than one person, the exact number to be determined, from time to time, in accordance with the By-Laws of the Corporation.

ARTICLE IX. Expenses (including attorneys' fees) incurred by any such person in defending any claim, action, suit, or proceeding may be paid by the Corporation in advance of the final disposition of such proceeding.


