The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I, NAME

The name of the corporation shall be ILDIKO ZOLD IMPORTS, INC.

ARTICLE II, NATURE OF BUSINESS
