ARTICLE I - NAME

The name of this Corporation is: GAETA DENTAL OF BONITA SPRINGS, P.A.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida. The specific purpose is the practice of dentistry.





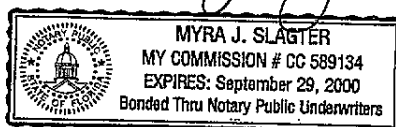
