**ARTICLES OF INCORPORATION**

**ARTICLE I. NAME**

The name of this corporation is ***BounceTime Rental, Inc.***

**ARTICLE II. DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
