I, the undersigned, hereby make, subscribe and acknowledge this Certificate for the purpose of becoming a Corporation under the Laws of the State of Florida.       

ARTICLE I - NAME AND DURATION

The name and address of the person signing these Articles is Jason Simone of 5815 Polk Street, Apt 1, Hollywood, FL 33021.


ARTICLE VIII - INDEMNIFICATION

ARTICLE IX - AMENDMENT


