ARTICLE I – Name

The name of this corporation is FAITH TRANSPORTATION, INC. The mailing address and the principal place of business shall be 1219 EAST PINE AVENUE, ORLANDO, FLORIDA 32824.

ARTICLE II – Duration

This corporation shall exist in perpetuity, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III – Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - Capital Stock

ARTICLE X – Amendment

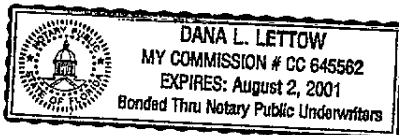
