**ARTICLES OF INCORPORATION
OF

The undersigned person, acting as incorporator of a corporation organized under the laws of Florida, hereby adopt the following Articles of Incorporation:

**ARTICLE I
CORPORATE NAME**

The name of this corporation is: **MORAGA'S EXPORT, CORP.**

**ARTICLE II
SHARES**

The total number of shares which the corporation shall have authority to issue is 100,000 shares of par value with a par value of \$1.00 per share.

After the initial board of directors, the board shall consist of such number of directors as shall be determined by the shareholders from time to time at each annual meeting at which directors are to be elected.


ARTICLE VI LIABILITY OF DIRECTORS

Any director or office who is involved in litigation or other proceeding by reason or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.
