I, the undersigned natural person(s), competent to contract, acting as incorporator of ribe, Oo Nicola corporation under the General Corporation Law of the State of Florida, make, subscribe, acknowledge and file the following Articles of Incorporation for such corporation.

ARTICLE I NAME OF CORPORATION
