Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

ARTICLE ONE

The name of the Corporation is C DELTA ENTERPRISES, INC. (the "Corporation").

The power to adopt, alter amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.

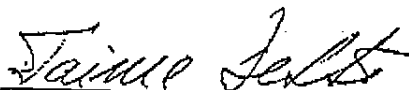
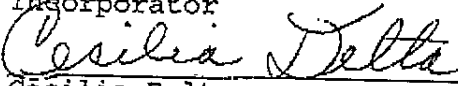
ARTICLE NINE
