SECRESIAND AND SHE ARTICLES OF INCORPORATION

The name of this corporation is: SANDRA'S NATURAL BEAUTY AND HEALTH, INC.

ARTICLE ONE

This corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

Without limiting any of the purposes, powers and objects of this corporation, it is expressly declared and provided that this corporation shall have power in carrying on its own business, or for the purpose of any lawful act or activity for which corporations may be organized under the laws of the State of Florida and accomplishment of any of the purposes or attainment of the objects herein above specified, to make and perform contracts of any and all powers, either as principal, agent or broker, conferred by Laws of Florida upon corporations, and which a partnership or natural person could do and exercise, and which now or hereafter may be authorized by law.

ARTICLE TWO

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is upon the filing of these Articles of Incorporation and upon acceptance by the Secretary of State.

ARTICLE THREE

This corporation is authorized to issue shares as follows:

- A. Designation: The stock of this corporation shall be known as Common Stock.
- B. Authorized: The maximum number of shares of Common Stock that this corporation may issue is: 100
- C. Par Value: Each share of Common Stock shall have no par value.
- D. Consideration: Shares of Common Stock may be issued in exchange for cash, real and personal property, labor or services rendered, or any combination of the foregoing. In the absence of fraud in the transaction, the judgment of the Board of Directors as to the value of any such consideration shall be conclusive.
- E. Non-accessibility: Each share of Common Stock shall be issued in exchange for consideration which is at least equal to the par value thereof, and shall be fully paid and non assessable.
- F. Voting Rights; Each holders of Common Stock shall entitle the record holder thereof have to one vote upon each proposal presented at meetings of the stockholders of the corporation.
- G. Dividends: Record holders of Common Stock are entitled to receive their pro-rata share of any dividends that bay be declared by the Board of Directors out of assets legally available for such
- H. Liquidation rights; Holders of Common Stock are entitled, in the event of the liquidation or dissolution of this corporation, to receive their pro-rata share of any assets of this corporation remaining after payment of all debts and obligations.

ARTICLE SIX INITIAL BOARD OF DIRECTORS

This corporation shall have initially one director. The number of Directors may be either increased or decreased from time to time by the By-laws but shall never be less than one director. The name(s) of the initial Director(s) of this corporation is(are):

ARTICLE SEVEN

The power to adopt, alter, amend or repeal By-laws shall be vested either in the Board of Directors or the Shareholders, but the Board of Directors may not amend or repeal any By-law adopted by shareholders if the shareholders specifically provide such By-law not subject to amendment or repeal by the directors.

ARTICLE EIGHT PREEMPTIVE RIGHTS

APPROVAL OF SHARESOLDERS REQUIRED FOR MERGER

The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or nor such approval is required by law.

ARTICLE ELEVEN DIRECTOR QUORUM AND VOTING

A majority of the Directors shall constitute a quorum for meeting of Directors. The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE THIRTEEN AMENDMENT
