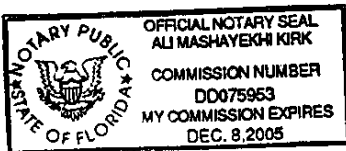
1. Susan M. Janis-Mashayekhi is the President of SJM PRODUCTIONS, INC., a Florida corporation, (hereinafter "Corporation").
