ARTICLES OF INCORPORATION
OF
THOMAS F. CONROY, M.D., P.A.

The undersigned, acting as incorporator of a Florida professional service corporation organized and existing under the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is: THOMAS F. CONROY, M.D., P.A.

ARTICLE II

CORPORATE ADDRESS

The street and mailing address of the initial principal office of the Corporation is 267 Sunset Drive North, St. Petersburg, Florida 33710. The Board of Directors of the Corporation may from time to time move the principal office of the Corporation to any other address in the State of Florida.

ARTICLE III

PURPOSES

The Corporation is organized for the following purposes:

1. To engage in every phase and aspect of the practice of medicine and all of its fields of specialization which the shareholders of the Corporation are duly licensed or otherwise legally authorized to render.
2. To render such professional services through its officers, employees, and agents who are medical professionals in good standing and are duly licensed or otherwise legally authorized to render such professional services within the State of Florida.
3. To invest its funds in real estate, mortgages, stocks, bonds, and any other type of investments permitted by law.
4. To own real and personal property necessary for the rendering of such professional services.
5. To engage in no other business other than the rendering of such professional services.

ARTICLE IV
CAPITAL STOCK

The Corporation is authorized to issue and have outstanding at any one time a maximum of 10,000 shares of common stock having a par value of \$.001 per share. Shares of the Corporation's stock and certificates therefor shall be issued only to medical professionals in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as the Corporation.

ARTICLE V

DIRECTORS

The business of the Corporation shall be managed by its Board of Directors. The number of Directors constituting the entire Board of Directors shall be no more or less than one (1) Director. The number of Directors may be increased or decreased from time to time by amendment of the Bylaws of the Corporation in a manner not prohibited by law; provided, however, until so changed the number of Directors shall be one (1) Director. 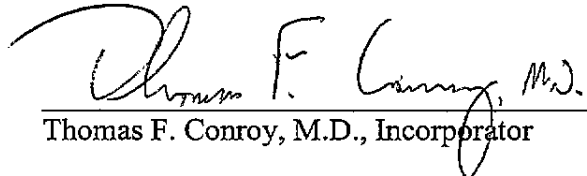

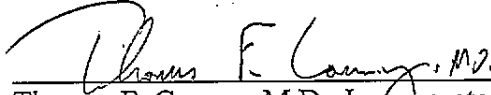

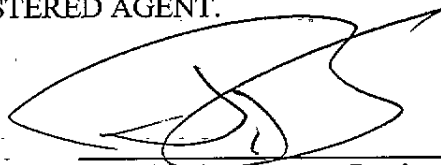
