The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional association (herein called the "Corporation") under Chapters 607 and 621, Florida Statutes, in the practice of certified public accountants.

ARTICLE FIRST. NAME

The name of the Corporation shall be Masters Avenue, Inc. The principal place of business of this Corporation shall be 6573 The Masters Avenue, Bradenton, Manatee County, Florida 34202.

ARTICLE SECOND. ADDRESS OF PRINCIPAL OFFICE

The Corporation's street address for its principal office and mailing address is 6573 The Masters Avenue, Bradenton, Florida 34202.

ARTICLE THIRD. NATURE OF BUSINESS

The purposes for which the Corporation is formed are to practice the profession of certified public accountant and to Engage in any lawful act or activity for which professional corporations or associations may be formed under Chapters 607 and 621 of the Florida Statutes.

This Corporation is to exist perpetually.

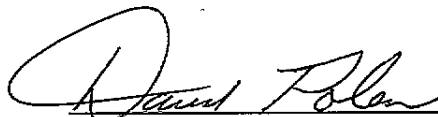
ARTICLE SEVENTH. SHARE REDEMPTION

Each Corporate Officer or Director is hereby relieved from any liability that might otherwise exist from contracting or dealing with the Corporation for the benefit of himself or of any firm, association, or corporation in which he may be interested, related or associated.

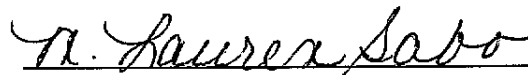
