

ARTICLES OF INCORPORATION OF DIRECT LINK MARKETING, INC.



ARTICLE I - NAME

The name of this corporation is DIRECT LINK MARKETING, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is 1,000 shares of common stock, having a par value of \$1.00 per share.
