ARTICLES OF INCORPORATION  
OF  
C.A.C.A., INC.  
a Florida corporation

ARTICLE I

The name of this corporation is C.A.C.A., Inc. The principal office of this corporation is 2076 Little Pine Circle, Punta Gorda, Florida 33955 and the mailing address of this corporation is Post Office Box 3606, Port Charlotte, Florida 33949.

ARTICLE II




