

ARTICLE I
Name

The name of this corporation is SURROUNDINGS POOL & PATIO, INC.

ARTICLE II
Duration

This corporation shall have perpetual existence.

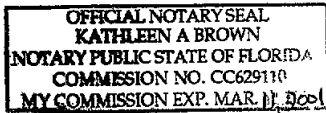
