ARTICLES OF INCORPORATION OF ROBERT D. LA BAR, P.A.

The undersigned, who is duly licensed to practice the profession of accounting in the State of Florida, desires to form a professional corporation pursuant to Section 621 of Florida Statutes for the purpose of rendering accounting services, and adopts the following Articles of Incorporation for such corporation.

ARTICLE I- NAME

The name of the corporation shall be ROBERT D. LA BAR, P.A.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- 1. To engage in every phase and aspect of the business of rendering the same accounting services to the public that an accountant, duly licensed under the laws of the State of Florida is authorized to render, provided such accounting services shall be rendered only through officers, employees and agents who are duly licensed or otherwise legally authorized to engage in the practice of accounting within the State of Florida.
- 2. To purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, deal in and with, real and personal property necessary for the rendering of accounting services.
- 3. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required.
- 4. To consolidate or merge with or purchase the assets of another doméstic professional corporation rendering the same professional services.
- 5. To invest in, purchase, or otherwise acquire, and to own, mortgage, pledge, sell assign, transfer, or otherwise dispose of real estate, mortgages, stocks, bonds or any other type of investment.
- 6. To engage in any other activity permitted under the laws of the United States or the state of Florida.

ARTICLE III - ADDRESS OF PRINCIPAL PLACE OF BUSINESS

The initial post office address of the principal place of business of this corporation in the State of Florida is: 731-8 NE 12th Terrace, Boynton Beach, Florida 33435.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares of common stock having a nominal or par value of One Dollar (\$1.00) per share. The whole or any part of the capital stock of this corporation may be paid for in lawful money of the United States of America or in property, labor or services at a just valuation to be fixed by the Directors. Stock shall be issued only to persons who are licensed to practice accounting in the state of Florida.

ARTICLE V - INITIAL CAPITAL

The amount of capital with which this corporation shall begin business shall be not less than Five Hundred (\$500.00) Dollars.

ARTICLE VI- TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VII - DESIGNATION OF REGISTERED AGENT AND OFFICE

The Registered Agent shall be: Robert D. La Bar, 731-8 NE 12th Terrace, Boynton Beach, Florida 33435.
