

ARTICLES OF INCORPORATION  
OF  
**G&R PAINTING & HOME IMPROVEMENT, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I – CORPORATION NAME**

The name of this corporation is **G&R PAINTING & HOME IMPROVEMENT, INC.**

**ARTICLE II – COMMENCEMENT OF CORPORATION**

The existence of the corporation shall begin on September 1, 2000.

**ARTICLE III – PRINCIPAL OFFICE AND ADDRESS**

The street address of the principal office of the corporation is 6732 Mediterranean Road, Orlando, Florida 32822.

**ARTICLE IV - PURPOSE**

The purpose of the corporation shall be to engage in the business of commercial and residential painting and improvement.

**ARTICLE V - DURATION**

The corporation shall have perpetual existence commencing at the time of filing these Articles of Incorporation.

**ARTICLE VI – CAPITAL STOCK**

The maximum number of shares this corporation is authorized to issue is 100, par value \$10.00 per share, all of which shall be common shares. 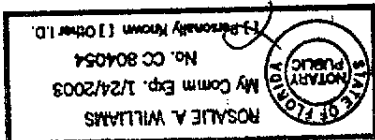


