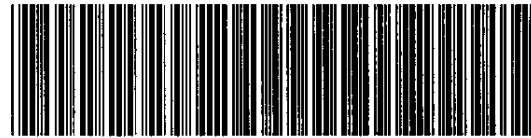

ARTICLE II


