ARTICLES OF INCORPORATION

OF

GEM CARPENTRY, INC.

ARTICLE I - NAME

The name of this corporation is Gem Carpentry, Inc. (hereinafter referred to as the "Corporation").

<u>ARTICLE II - DURATION</u>

The Corporation shall exist perpetually, commencing on the date of filing of these Articles with the Department of State.
