### ARTICLES OF INCORPORATION

OF

### SMART SELLING, INC.

The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.

### **ARTICLE I**

The name of the corporation (hereinafter called the corporation) is:

The duration of the corporation shall be perpetual.

convertible into or exchangeable for, or which carry any rights, to subscribe for, purchase, or otherwise acquire shares of any class of the corporation; and any and all of such shares, bonds, securities or obligations of the corporation, whether now or hereafter authorized or created, may be issued, or may be reissued or transferred if the same have been re-acquired and have treasury status, and any and all of such rights and options may be granted by the Board of Directors to such persons, firms, corporations and associations, and for such lawful consideration, and on such terms, as the Board of Directors in its discretion may determine, without first offering the arms, or any thereof, to any said holder.
