ARTICLES OF INCORPORATION OF MOSTAZA CHRISTIAN BOOK STORE, MUSIC AND CAFÉ, INC.

THE UNDERSIGNED, have executed the following document as incorporator of the above named Corporation, organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporator, and those of the Corporation, are to be defermined in accordance with the laws of the State of Florida.
