ARTICLES OF INCORPORATION OF BUNCE DIVERSIFIED, INC.

ARTICLE I - NAME

The name of this corporation shall be Bunce Diversified, Inc..

ARTICLE II - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock this corporation shall be authorized to have outstanding at any one time shall be **seven thousand five hundred (7,500)** shares of common stock of the par value of one dollar (\$1.00) per share, upon which there are no preemptive rights except to the extent specified by the By-Laws.
