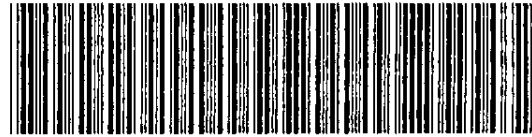

ARTICLE III. CAPITALIZATION

The corporation shall have authority to issue two (2) classes of shares as follows;

Five Thousand Shares of Class A Common Shares having voting rights and Five Thousand Shares of Class B Common Shares having no voting rights. Each Share shall have a par value of One Dollar (\$1.00). Other than the entitlement to voting or not voting of the Shares, all Shares shall have the same preferences, limitations and relative rights and are entitled to share in the net assets of the corporation upon dissolution or sale.
