The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME.

The name of this corporation is shoppingoverseas.com, INC. The principle place of business of this corporation shall be 4967 S.W. 75th Avenue Miami, Florida 33155.

ARTICLE II.

NATURE OF BUSINESS.
