Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the Shareholders is subject to this reservation.
