The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is CompuSkills, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of the corporation will be to operate a school as defined in Section 246.203(1), Florida Statutes upon obtaining the required license from the State Board of Nonpublic Career Education and any other lawful purpose.

ARTICLE IV - ADDRESS

ARTICLE V - CAPITAL STOCK
