

The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation.

#### <u>ARTICLE I - NAME</u>

The name of this Corporation is CompuSkills, Inc.

## ARTICLE II - DURATION

The Corporation shall have a perpetual existence.
