

ARTICLES OF INCORPORATION

OF

NIGHTINGALE NURSE REGISTRY, INC.

We the undersigned do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, and do hereby adopt the following articles of incorporation:

ARTICLE I

The name of this corporation shall be Nightingale Nurse Registry, Inc.

ARTICLE II

The purposes for which this corporation is formed are as follows:

To transact any or all lawful business in which a corporation may be engaged in the State of Florida.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is four thousand shares of \$1.00 par value, common stock.

ARTICLE IV

This corporation is to exist perpetually.

ARTICLE V

The principal place of business of this corporation shall be located at 1014 Edgewater Court, Orlando, Florida, 32804 and it may have such other places of business, both within and without the State of Florida, and in foreign countries, as may be necessary and convenient.

ARTICLE VI

The Board of Directors of this corporation will consist of not fewer than one member initially. The number may be increased from time to time, but shall never be fewer than one.
