ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation.

ARTICLE I

The name of this corporation is Pedro Arcia, P.A.

ARTICLE II

The existence of the corporation shall begin on September 8, 2000.

ARTICLE III

ARTICLE IIX


The purpose of this corporation shall be real estate and time share sales and any other lawful purpose.
