ARTICLES OF INCORPORATION

OF

AYERS CARS AND LEASING, INC.

We, the undersigned, hereby make, subscribe, acknowledge, and file these articles for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation is: AYERS CARS AND LEASING, INC.

ARTICLE II

EFFECTIVE DATE/EXISTENCE

The Corporation shall have perpetual existence.

ARTICLE III

PURPOSE
