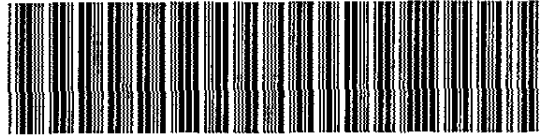

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
SIRI SREE CORPORATION**

Siri Sree Corporation, pursuant to Section 607.1001, 607.1003 and 607.1006, Florida Statutes, does hereby adopt and file the following Articles of Amendment to Articles of Incorporation:

1. Notwithstanding the provisions of the Articles of Incorporation of the Corporation to the contrary, the Corporation is hereby authorized to secure financing (the "Loan") for the Corporation from Investment Property Mortgage, L.L.C., a Louisiana limited liability company, or Column Guaranteed, LLC, a Delaware limited liability company, in such amount and on such terms as the signing officer of the Corporation may elect, and to grant a mortgage, deed of trust, lien or liens on the Corporation's property to secure such Loan, as well as incur other indebtedness to the extent expressly authorized pursuant to the documents further evidencing the Loan.

2. Until the Loan is repaid in full, Chowdary Yalamanchili shall not transfer all or any portion of his interest in the Corporation.

3. That the foregoing amendment was recommended, adopted and authorized by all of the common stock Shareholders and all of the members of the Board of Directors of the Corporation, pursuant to a Joint Written Action dated October 17, 2003.
