**ARTICLE OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
CENTRAL FLORIDA PULMONARY CRITICAL CARE SPECIALISTS, P.A.**

Central Florida Pulmonary Critical Care Specialists, P.A., a Florida corporation organized and existing under laws of the State of Florida (the "Corporation"), in order to amend Article I of its Articles of Incorporation, does hereby certify as follows:

1. The Articles of Incorporation were filed on September 8, 2000.
2. The amendment effected by the present Articles of Amendment will change the name of the Corporation to "Sergio L. Balingit, Jr. M.D., P.A."
