ARTICLES OF INCORPORATION

OF

I, the undersigned incorporator, do hereby make, subscribe, execute, acknowledge, and deliver for filing this Certificate of Incorporation for the purpose of organizing a corporation COLORED S PA H: 59 under the Florida Business Corporation Act.

ARTICLE I. NAME


