ARTICLES OF INCORPORATION

OF

ARM RETAIL, INC.

The undersigned, of legal age, hereby form this corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation shall be ARM RETAIL, INC.

GENERAL NATURE OF BUSINESS


ARTICLE X.


