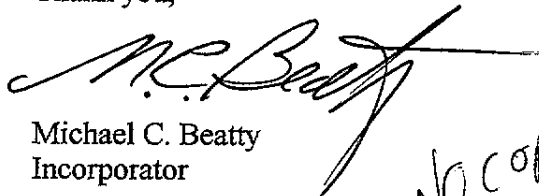

ARTICLE I

NAME

### BYLAWS

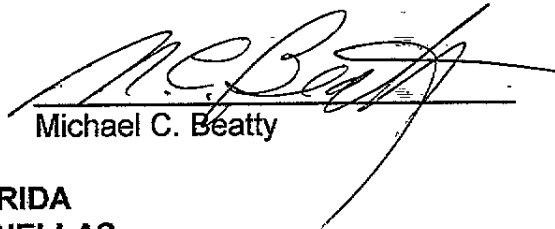

AMENDMENT

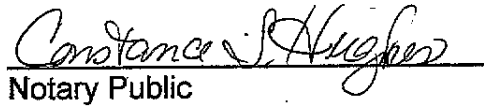
