ARTICLES OF INCORPORATION
OF
SAMSON ISLAND VIEW, INC.

ARTICLE I. NAME

The name of this corporation is
SAMSON ISLAND VIEW, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of
transacting any or all lawful business.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 100 shares of
\$1.00 par value common stock, which shall be designated
"common shares".

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new

purchase his pro rata share (as nearly as may be done without
issuance of fractional shares) at the price at which it is




