

*Pursuant to 607.1401, Florida Statutes, this Florida profit corporation submits the following articles of dissolution:*


- FIRST:** The name of the corporation is DEFOOR, INC.

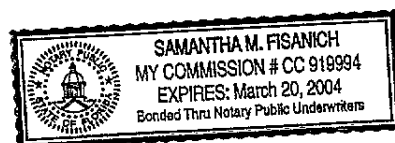
