ARTICLE I NAME

The name of this corporation is: ADVANTAGE MOVING SYSTEMS, INC.

ARTICLE II DURATION

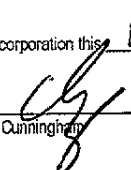
ARTICLE IX BY-LAWS

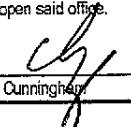
