**ARTICLE I - NAME**

The name of the corporation is Total Design Systems, Inc., (hereinafter called the "corporation")

The name of the incorporator is Nancy Blanco and the address of the incorporator is 8130 NW 67<sup>th</sup> Street, Miami, FL 33166.


**ARTICLE VIII - BYLAWS**
