ARTICLE I. NAME.

The name of this corporation is **BEUCHER INSURANCE, INC.** The effective date of this corporation shall be October 1, 2000.

ARTICLE II. DURATION.

The period of its duration is perpetual.

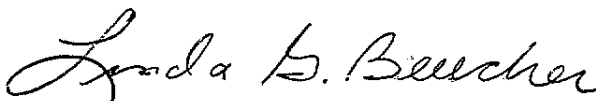
ARTICLE IX. AMENDMENT OF ARTICLES.
