**ARTICLES OF INCORPORATION**

WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation for profit under the laws of the State of Florida.

**ARTICLE I**  
**NAME**

Section 1.1. The name of the corporation is J.A.R.C. CORPORATION (the "Corporation").

**ARTICLE II**  
**DURATION**

Section 2.1. The Corporation shall have perpetual existence unless dissolved pursuant to law.

**ARTICLE III**  
**PURPOSE**

Section 3.1. The general nature of the business to be transacted by this Corporation and its purpose is to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services, of every class, kind and description, or any other business activity permitted under the laws of the United States and the State of Florida.

**ARTICLE IV**  
**PREEMPTIVE RIGHTS GRANTED**

Section 4.1. Each shareholder of any class of stock of this Corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the Corporation and any securities of the Corporation convertible into or carrying a right to subscribe to or acquire shares of unissued or treasury shares.

**ARTICLE V**  
**REGISTERED OFFICE**

Section 5.1. The address of the initial Registered Office of the Corporation is 6071 Dartmouth Ave. N., St. Petersburg, FL 33710. The initial Registered Agent at this address will be Joan Cifaldo.

**ARTICLE VI**

**ARTICLE VII**  
**CAPITAL STOCK**

Section 7.1. The Corporation is hereby authorized to issue One Hundred (100) shares of common stock with the par value of One Dollar (\$1.00) per share.


