ARTICLES OF INCORPORATION

OF

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: A 1 CARPET & DRAPERY CARE, INC.

ARTICLE II. NATURE OF BUSINESS
