The undersigned, whom is duly licensed to engage in the practice of Internal Medicine within the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - CORPORATE NAME

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida Law.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized shall be to engage in the practice of Internal Medicine within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.




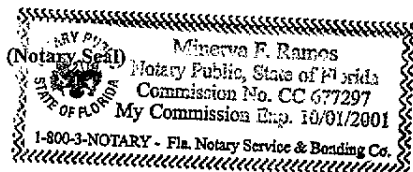
