ARTICLES OF INCORPORATION 00 SEP -8 AM 9: 42

CLEARSWIM POOL CLEANING,

The undersigned Subscriber, a natural person competent to contract, desires to form a Corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is CLEARSWIM POOL CLEANING, INC. and the principal office and address is: 11702 Gran Crique Court, North Jacksonville, FL, 32223.
