**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

**Article I  
NAME**

The name of the corporation is THE GROVES HOUSING ASSOCIATES, INC.

DURATION**

This corporation shall exist perpetually.

**Article VI**  
**INITIAL REGISTERED OFFICE AND AGENT**

**DIRECTORS**


