OF

ARTICLE V - ADDRESS OF PRINCIPAL OFFICE

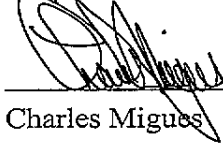

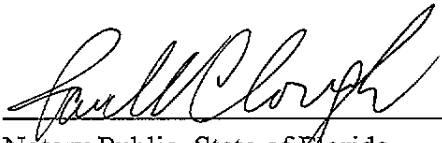
