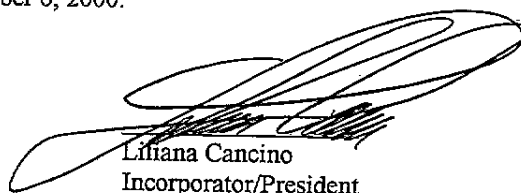

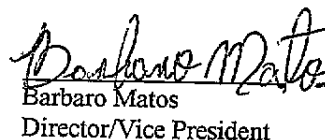

ARTICLE VII AMENDMENTS

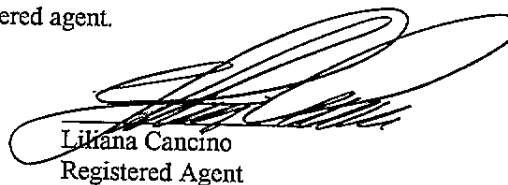

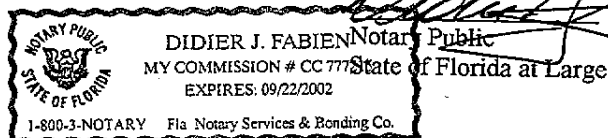
